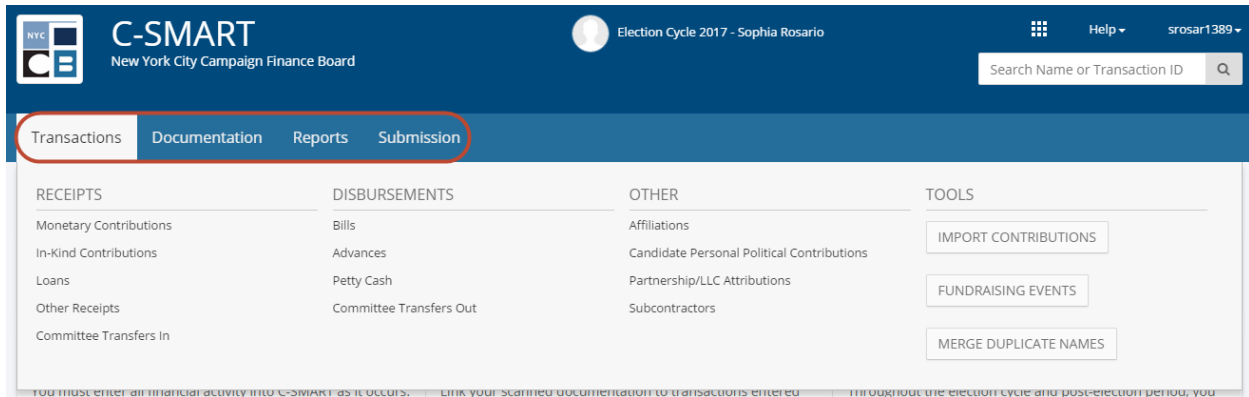


Help Content: Home Page

From the **Home Page**, you can access all of the functions available in C-SMART. The Home Page also displays key dates, a financial summary, and shortcuts to commonly-used functions. You can always return to the Home Page from anywhere in C-SMART by clicking the CFB logo in the upper left corner of the page.

Tab Menus

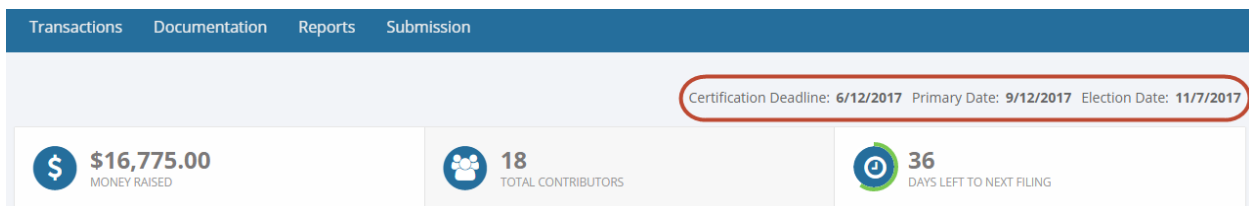
The tab menus are used to navigate through C-SMART. You can access each menu by hovering your mouse over the tab and clicking on the applicable item.



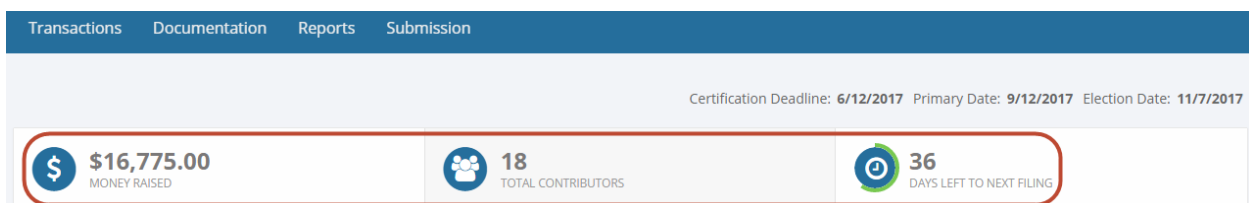
Reminders

Toward the top of the page, C-SMART will remind you of the following dates:

- Certification Deadline- the deadline to submit a Certification to join the [Matching Funds Program](#) for the selected election cycle
- Primary Date- the date of the primary election for the selected election cycle (if applicable)
- Election Date- the date of the general election for the selected election cycle (for special elections, this is the date of the special election)




C-SMART will also display the number of days until the next [disclosure statement deadline](#), in addition to your total funds raised and total number of contributors.

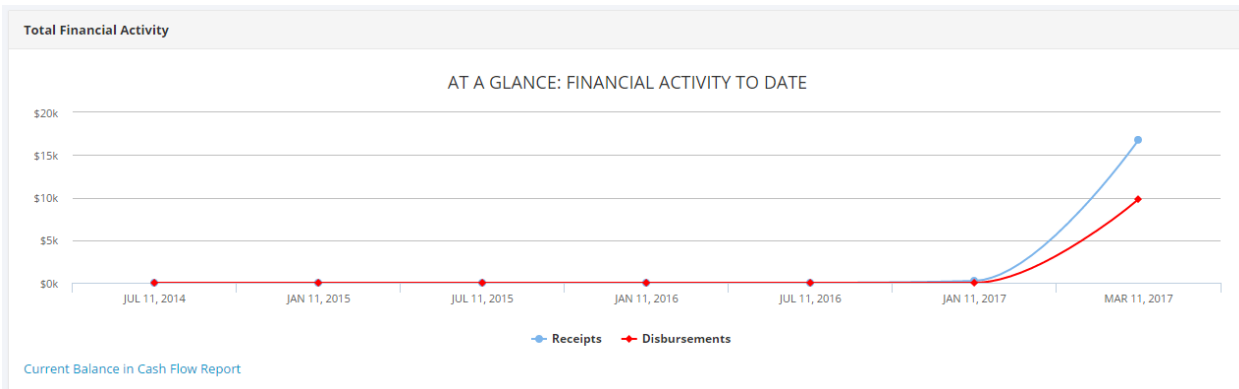
